These items are state-specific and are in addition to the Federal Stimulus Package items.

STATE STIMULUS PACKAGES

NSW - NEW SOUTH WALES

- Payroll tax waived for businesses with payrolls of up to \$10 million for 3 months (the rest of 2019-20). Businesses will save a quarter of their annual payroll tax bill in 2019-20
- \$56 million to bring forward the next round of payroll tax cuts by raising the threshold limit to \$1 million in 2020-21
- \$80 million to waive a range of fees and charges for small businesses including bars, cafes, restaurants and tradies
- NSW will spend \$250 million to employ additional cleaners of public infrastructure such as transport assets, schools and other public buildings
- More than \$250 million to bring forward maintenance on public assets including social housing and crown land fencing. \$500 million to bring forward capital works and maintenance.
- \$700 million extra funding for NSW Health to double ICU capacity, prepare for additional COVID-19 testing, purchasing additional ventilators and medical equipment, establishing acute respiratory clinics and bringing forward elective surgeries to private hospitals.
- NSW Government has amended the Environmental Planning and Assessment Act to ensure that any development that protects the health, welfare and safety of the community during the pandemic can proceed without the normal development approvals.
- Long Service leave rules have been amended to allow employees to take leave in shorter blocks without the traditional one-month notice period, by agreement with their employer for the until September 2020.

STATE STIMULUS PACKAGES

NSW - NEW SOUTH WALES

- NSW workers and businesses are now able to access a range of advice and support on non-health related COVID-19 enquiries via the Service NSW contact centre 13 77 88
- Police will have the power to issue \$1000 on-the-spot fines for individuals and \$5000 for corporations not complying with ministerial directions relating to COVID-19. Members of the public can report breaches of COVID-19 public health orders at www.nsw.crimestoppers.com.au or call 1800 333 000

NSW 2ND STAGE STIMULUS PACKAGE

- \$1 billion Working for NSW fund to sustain business, create new jobs and retrain employees. The fund is already being put in to action with 1000 new staff for Service NSW announced this week to be funded by the program. The Working for NSW fund will comprise \$750 million in new funding and \$250 million announced last week for additional cleaning services
- Deferral of payroll tax for business with payrolls over \$10 million for six months (up to \$4 billion deferred). Businesses with payrolls of \$10 million or less received a three-month waiver on payroll tax in the first package. These businesses will now get an additional three month deferral as well
- Deferral of rents for six months for commercial tenants with less than 20 employees in all Government-owned properties. Deferral of the parking space levy for six months
- \$30 million to boost the Energy Accounts Payments Assistance scheme
- \$10 million to support charities and \$6 million additional funding for Lifeline's operations in NSW. \$34 million boost in funding to prevent homelessness

NSW - NEW SOUTH WALES

- **Faster Payments scheme** - The NSW Government is fast-tracking the payment of suppliers and contractors to help businesses maintain their cash flow. Suppliers to benefit will include a range of small to medium businesses from catering and cleaning companies, medical supply companies, local regional suppliers and community service groups.
- Construction sites can now operate on weekends and public holidays under new rules introduced today by the NSW Government to support the industry during the COVID-19 pandemic. The Environmental Planning and Assessment (**COVID-19 Development – Construction Work Days**) Order 2020 is now in place and will continue until the COVID-19 pandemic is over, or the advice of NSW Health changes.

The Planning System Acceleration Program

- create opportunities for more than 30,000 construction jobs in the next six months
- fast-track assessments of State Significant Developments, rezonings and development applications (DAs), with more decisions to be made by the Minister if required
- support councils and planning panels to fast-track local and regionally significant DAs
- introduce a 'one stop shop' for industry to progress projects that may be 'stuck in the system'
- clear the current backlog of cases stuck in the Land & Environment Court with additional Acting Commissioners
- invest \$70 million to co-fund vital new community infrastructure in North West Sydney including roads, drainage and public parks to unlock plans for the construction of thousands of new houses.

\$750 million Small Business Support Fund

- Eligible businesses must have between 1-19 employees and a turnover of more than \$75,000
- a payroll below the NSW Government 2019-20 payroll tax threshold of \$900,000
- have an Australian Business Number as at 1 March 2020, be based in NSW and employ staff as at 1 March 2020
- be highly impacted by the Public Health (COVID-19 Restrictions on Gathering and Movement) Order 2020 issued on 30 March 2020
- use the funding for unavoidable business costs such as utilities, overheads, legal costs and financial advice
- provide appropriate documentation upon application.
- Applications for a small business grant of up to \$10,000 will be available through Service NSW within a fortnight and remain open until 1 June 2020.

ACT - AUSTRALIAN CAPITAL TERRITORY

- Rebates of \$150 on residential rates for Canberra households. These will be automatically applied to 2020-21 rates bills.
- Freeze on Government fees and charges, including the fire and emergency services levy, public transport, vehicle registration and parking fees. These will be automatically applied to 2020-21 rates bills.
- Rebate on the fixed charge for 2019-20 on commercial rates for properties with an AUV below \$2 million. Targeted at businesses who own their own premises.
- Interest free deferrals of payroll tax from 1 July 2020 for all businesses up to a payroll threshold of \$10 million. Businesses will need to complete a simple online application form (which will be available soon on the ACT Revenue Office website at: www.revenue.act.gov.au) to confirm their eligibility.
- The ACT Government is providing \$20 million to fast track infrastructure projects and maintenance on government-owned community, school and other buildings as well as suburb maintenance. The program will focus on: works that can start immediately, be undertaken using local suppliers and workers, and meet social distancing requirements. This fund will be utilised this financial year.
- The Government will provide more funding for the removal of dead trees, planting of new trees and maintenance of surrounding areas to redeploy existing government contractors impacted by event cancellations.
- Prioritised processing of development applications.
- The Government will delay the issuing of all general rates notices by four weeks, and push back payment dates by that time, to allow people eligible for Commonwealth assistance to start receiving it.

- 'Homefront' survival package funding up to \$10,000 per artist will be available to support arts development and the sustainability of their arts practices over the next 6-9 months. A total of \$500,000 will be available for Canberra's artists and creatives. Applications will open on 30 March 2020 and will close on 17 April 2020 at 5pm. [MORE DETAILS](#)
- Electricity rebates: Small business owners with electricity usage below 100 megawatts per year will see rebates of \$750 automatically applied to their next electricity bill in around June or July 2020. The rebate will apply regardless of whether customers are on standing or market offers. You do not need to contact your electricity supplier as this will be automatically applied.
- Commercial property owners with an Average Unimproved Value of \$2 million or less on their property are eligible for a rebate on their commercial rates fixed charge. Commercial rate payers will receive a credit of \$2,622 (equivalent to the annual fixed charge) to their 2019-20 general rates, in quarter four. This will be applied automatically. Where rate payers have paid in full or have a quarter bill less than the credit, they will be eligible for a refund. Businesses will need to complete a simple online application form (which will be available soon on the [ACT Revenue Office website](#)) to apply for a refund.
- The ACT Government is relaxing parking restrictions in various areas of the city to support Canberrans to collect take away food and services from local restaurants and cafes. Signs will start going up in areas such as Braddon, Woden, Belconnen and Tuggeranong attached to the existing parking signs.
- **Jobs for Canberrans** - fund will allow ACT Government Directorates to continue employing people for cleaning, repairs and maintenance projects. This fund will focus on providing secure work opportunities for Canberrans who have relied on casual work and are not eligible for the Commonwealth's wage subsidy scheme.

- ACT Government will encourage landlords to reduce rents by at least 25 per cent for tenants under rental stress by sharing the cost reduction of the rental on a 50/50 basis, capped at \$1,300 per quarter (around \$100 a week)
- Any owner occupier in the Territory experiencing hardship because of COVID-19 will be eligible for a deferral of their general household rates for 12 months. No interest will be applied to the deferred amount.
- Depending on the level of hardship commercial tenants are facing, landlords will be eligible to apply for a waiver or rebate on their commercial rates, tied to the rental relief passed onto their tenants.
- The construction industry is vital to the long-term economic survival of the nation's economy. While the sector is continuing to operate under physical distancing requirements, there may be impacts to the financial viability of construction businesses in the weeks and months ahead. To protect as many jobs as possible in the industry, the ACT Government is enabling businesses in the construction sector to access interest free payroll tax deferrals for six months.
